2019 4-H Video Contest

Do you love 4-H and have a knack for creating digital content? If so, this video contest is for you!

Objective: Promote *Williams County* **4-H** in a 90 second video or less.

Eligibility: Any current 4-H member (Cloverbuds not eligible).

Deadline: January 15, 2019

Terms of Use:

- 1. Emphasis should be on promoting Williams County 4-H (including such aspects as: what there is to love about 4-H, how 4-H grows youth, and the benefits of 4-H).
- 2. This video's sole focus should not be on club promotion within the program. It's okay if a specific club is mentioned, as part of the 4-H experience.
- 3. Any use of the 4-H clover must be the original emblem with the (18 USC 707 code under the bottom right of the clover). The official 4-H emblem must not be altered in any way.
- 4. Can be a combination of video footage, photos, and/or powerpoint slides, but not solely done via powerpoint.
- 5. Involve 4-H members who **consent** to be used in the video for the ultimate goal of promoting the program. (The winning video will need to have any 4-H members used in the video to sign a photo release form)
- **6.** Students may work together in groups or submit entries as individuals.—but the prize will remain the same.
- 7. Content must comply with all local and national laws of the United States. Content must not 1) promote illegal behavior; 2) support racial, religious, sexual or other invidious prejudice; 3) advocate sexual or violent exploitation; 4) violate rights established by law or agreement; 5) invade the privacy of any person; or 6) be otherwise inappropriate as determined by The Ohio State University or 4-H.
- 8. All entries must be submitted in digital format.
- **9.** No professional assistance is allowed. Adults may assist with production but are limited to verbal guidance only. Adults are allowed to be actors or cameramen but not content contributors. The goal of this contest is to be youth driven!
- **10.** No copyrighted materials (music, images, etc.) may be used for this contest unless you own the copyright or have a license to use the material for this contest. Written permission must be obtained and provided upon request for all copyrighted materials.
- 11. The judges' decision is final.
- 12. **To submit your entry**: Upload your video to YouTube, but the video needs to be "unlisted or marked private" so that the video is not available to the public and then email the link to perry.1735@osu.edu

The reward: The winning video will be awarded a \$200 visa gift card and will be used for marketing/promotional initiatives for the Spring Kick-Off and Ohio 4-H week in March. All entries agree for Williams County 4-H to use for local promotion of Williams County 4-H.
